

Manna Pro Products Stars, Strips and Savings Sweepstakes

Official Rules of Play

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1) ELIGIBILITY: Sweepstakes open to all legal residents of the United States and Canada (except Quebec), who are 18 years of age or older as of June 1, 2009, except the owners, employees and their immediate families (spouses and parents, siblings and children and their respective spouses, regardless of where they reside), and their respective household members, whether or not related, of Manna Pro Products, LLC (the "Sponsor"), its subsidiaries, affiliates, dealers, promotion and advertising agencies, and any other company involved with the design, production, execution or distribution of the materials for the Stars, Stripes and Savings Sweepstakes (the "Sweepstakes"). All entries become the property of Sponsor and will not be returned.

3) WINNER SELECTION: A random drawing will be conducted by the Sweepstakes Administrator in St. Louis, MO on September 10, 2009, and potential winner will be notified by phone or mail within ten (10) business days. Potential winner will be selected and verified by an independent judging organization whose decisions are final in all matters relating to the Sweepstakes. If potential winner is a resident of Canada, he/she will be required to correctly answer a mathematical skill testing question, without assistance of any kind, whether mechanical or otherwise, as a condition of being awarded the prize. The mathematical skill testing question will be administered during the verification process. All materials submitted become the property of the Sponsor and will not be returned.
